Essential Duties and Responsibilities

Staff Management

- Communicating staff responsibilities for the day (i.e., monitoring needs, site checks, pre-con surveys, nesting bird surveys, den observations).
- Managing shifting responsibilities throughout the day and week.
- Serving as primary contact to resolve immediate issues and questions (safety, non-compliance).
- Ensuring the safety of staff (i.e., rotating staff for rest breaks, cool down breaks as necessary with weather and task in mind).
- Training and providing guidance to new staff.

Client/EPC On-site Management

- Informing client/EPC of any potential issues and troubleshooting as issues arise.
- Providing WEAP training to all project members.
- Serving as primary contact for client/EPC for site and/or work updates.
- Communicating site changes to staff.
- Managing timely resolution of non-compliance issues.
- Acting as Ironwood's onsite bio-representative for agencies.

Resource Management

- Ensuring natural resources are protected, including nesting birds, desert kit fox, desert tortoise, and plants.
- Ensuring daily weekly, monthly, quarterly compliance checks are completed.
- Ensuring appropriate data is collected according to guidelines.

Communication

- Checking and responding to internal direct messages regularly; communicating updates to staff.
- Leading daily worksite meetings.
- Conducting scheduled safety checks.
- Informing PM of any potential staff or project issues.
- Participating in weekly project management calls.

Scheduling

• Assigning scheduled staff to appropriate tasks, communicating in advance.

<u>Reports</u>

- Conducting weekly compliance monitoring reports, resource activities, and ongoing worksite issues reports.
- Informing Project Manager and following week's onsite DB if there are potential issues.

- Bachelor's degree (BA) from 4-year college or university (in the field of biology, botany, ecology, or environmental science).
- 4 to 5 years related field experience.
- At least 2 years of supervisory/DB experience.
